**IN EXCHANGE FOR ADMISSION AND/OR PARTICIPATING IN SCV PROGRAMS OR EVENTS, EACH VISITOR FULLY WAIVES, RELEASES, DISCHARGES, AND COMMITS TO INDEMNIFY AND FOREVER HOLD SCV HARMLESS FROM ANY AND ALL CLAIMS, LIABILITIES, AND CAUSES OF ACTION OF ANY KIND, INCLUDING CLAIMS RELATING TO EXPOSURE TO COVID-19, ARISING FROM THE VISITOR'S PARTICIPATION OR PRESENCE, AND INCLUDING ANY DAMAGES, INJURIES, OR HARM WHICH MAY BE CAUSED BY CONDITIONS, OCCURRENCES, ACTS, OR OMISSIONS DURING OR RESULTING FROM THE VISIT OR PARTICIPATION, INCLUDING ANY INJURY, HARM OR LIABILITY CAUSED BY THE NEGLIGENCE OF ANY KIND OR OTHER ALLEGED WRONGDOING OR FAULT OF SCV, EVEN IF THE VISTOR CLAIMS THAT SCV WAS SOLELY AT FAULT UNDER ANY THEORY.**

The privilege of access to SCV premises and programs and events may be revoked at any time in SCV's sole discretion, and SCV may refuse admission or expel any person whose conduct is objectionable. As a guest, each visitor must comply with all safety rules, observe all warnings, and follow instructions given by staff and/or security officers.
